- 2 2-103.11 (M) Person in Charge-Duties - (PF)- Three employees were asked to identify symptoms or illnesses they could not work with or if there was a paper where they could find this information. All three employees only listed one illness. Employees as well as PIC shall be able to identify illnesses/ symptoms that exclude or restrict employees from work. Ensure food employees are informed of their responsibility to report required symptoms, illnesses and exposure. CDI- PIC showed REHS employee health policy. PIC stated he would place a copy around facility.
- 7 3-301.11 Preventing Contamination from Hands - (P)- Upon arrival employee preparing lettuce with bare hands. Lettuce is used for a topping on wraps thus a ready to eat item. Do not contact exposed ready-to-eat food with bare hands. Use suitable utensils, single-use gloves or dispensing equipment. Lettuce was discarded, employee washed hands and put on gloves.
- 21 3-501.17 Ready-To-Eat Potentially Hazardous Food (Time/Temperature Control for Safety Food), Date Marking - (PF)- REPEAT- Multiple items such as watermelon, and prepared gyro meat were date marked with the dates of 12-2 to 12-9. Food that is prepared and held in a food establishment for more than 24 hours shall be marked to indicate the date or day by which the food shall be consumed on the premises, sold, or discarded, based on the temperature and time combinations specified below. The day of preparation shall be counted as Day 1. CDI- all dates of this range were changed to 12-2 to 12-8

- 35 3-302.12 Food Storage Containers Identified with Common Name of Food - REPEAT (improvement from last inspection). Four bottles near front make unit did not contain labels. Unless a food can be easily recognized, working containers holding food or food ingredients shall be labelled with the common name of the food.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - REPEAT- (improvement from last inspection)- Repair/ replace rice warmer handle that is missing. Repair deep cuts on make unit door. Equipment shall be maintained in a state of good repair.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - REPEAT- Shleving/ racks throughout facility require additional cleaning. Non-food contact surfaces of equipment shall be cleaned at frequency to prevent accumulation of soil residue.
- 53 6-201.11 Floors, Walls and Ceilings-Cleanability - fill holes on wall near three compartment sink where there was once something hung. Repair low floor grout near make unit on front line. Establishment must provide floors, floor coverings, walls, wall coverings, and ceilings that are designed, constructed and installed so they are smooth and easily cleanable.
