

CDI-Moved items from Mongolian station to walk in to cool back down. Get two door cooler checked and repaired if needed to maintain cold foods.
- 49 5-205.15 (B) System maintained in good repair - C- Constant and steady leak from water dial at can wash. Maintain plumbing in good repair.
