When the package of food is opened, store foods according to cooking temperatures in the freezer. CDI: Person in charge removed and properly stored the raw chicken.
- 18 3-501.14 Cooling - P Chip beef 50 F at 10:38am and 45 F at 11:22 am covered in the reach in cooler. Cooked POTENTIALLY HAZARDOUS FOOD (TIME/TEMPERATURE CONTROL FOR SAFETY FOOD) shall be cooled: (1) Within 2 hours from 57°C (135°F) to 21°C (70°F); P and (2) Within a total of 6 hours from 57°C (135°F) to 5°C (41°F) or less. CDI: Employee discarded the chip beef.
- 20 3-501.16 (A)(2) and (B) Potentially Hazardous Food (Time/Temperature Control for Safety Food), Hot and Cold Holding - P Cut tomatoes in salad 40 F to 44 F in container on top ice bath located in the holding unit. Cold holding potentially hazardous foods shall be maintained at 41 F or less. CDI: Educated person in charge about cold holding temperatures and have a surrounding ice bath to the level of the food.

- 31 3-501.15 Cooling Methods - PF Chip beef 50 F at 10:38am and 45 F at 11:22 am in covered, plastic container with condensation inside the reach in cooler. Cooling shall be accomplished by using one or more of the following methods: 1. Shallow pans, 2. Smaller or thinner portions, 3. Rapid cooling equipment, 4. Stir the food in container placed in an ice water bath, 5. Use containers that facilitate heat transfer, 6. Add ice as ingredient or 7. Other effective methods. In cold holding equipment, food shall be: 1. Arranged to provide maximum heat transfer and 2. Loosely covered or uncovered if protected from overhead contamination. CDI: Employee discarded the chip beef.
- 37 3-307.11 Miscellaneous Sources of Contamination - Repeat. Small ice build up on wrap of ravioli and mac n cheese inside the walk in freezer. Food shall be protected from contamination.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Repeat. Caps missing on the floor panels in the walk ins. Torn gasket on the door of the walk in freezer. Equipment shall be maintained in good repair.
