- 13 3-302.11 Packaged and Unpackaged Food-Separation, Packaging, and Segregation - P- Inside of the Victory freezer raw chicken that had been removed from its original packaging was stored in contact with a box of pastry. Inside of the True three door refrigerator raw beef and pork was stored in a pan with ready-to-eat turkey and inside of the True two door refrigerator eggs and raw bacon was stored above milk and ready-to-eat foods- Food shall be protected from cross-contamination by separating raw animal foods during storage, holding, preparation and display from cooked ready to eat foods and other raw animal foods by stacking order from top shelf to bottom shelf having items with the highest required cooking temperature for safety on the bottom- CDI: The items were arranged according to approved standards by the person-in-charge (PIC).
- 39 3-304.14 Wiping Cloths, Use Limitation - C- A cloth for wiping was stored inside of a bucket in a solution that was measured at 0ppm sanitizer concentration- Cloths in-use for wiping counters and other equipment surfaces shall be held between uses in a chemical sanitizer solution at a concentration specified under § 4-501.114- 0 pts.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C- REPEAT- Repair is needed for the following pieces of equipment: replace the non-functioning light bulb in the hood exhaust system and repair or replace the caulking at the panel junctions, completely cover or fill the holes in the backsplashes of the three compartment sink and the dishmachine drainboard to create a smooth and easy to clean surface, recondition the undersides of the 3 compartment sink and prep sink drainboards to remove rusting and repair or replace the torn door gaskets in the refrigeration equipment- Equipment shall be maintained in a state of good repair.
