- 26 7.202.11 Restriction-Presence and Use - PF Glass cleaner was stored beside pans on a bottom shelf. Glass cleaner is not to be store in the kitchen.
- 39 3-304.14 Wiping Cloths, Use Limitation - C One wiping cloth on a work table near the steam table; wiping cloths shall be clean and dry and used only to wipe food spills or wet and stored in sanitizer.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Need to replace serving trays with wire showing, split gaskets in up right refrigerators, and cracked ice scoop. Need to repair gauges on dish machine.
- 47 4-602.13 Nonfood Contact Surfaces - C Need to clean the handles of the 3 door true refrigerator.
- 54 6-303.11 Intensity-Lighting - C Need to repair light fixture over steam table prep area, low light today.
