- 6 2-301.14 When to Wash - P Employee observed using cell phone and handling equipment handles without washing hands. Employees shall wash hands when contaminated. Employee washed hands as corrective action.
 2-301.12 Cleaning Procedure - P Employee washed hands and turned off faucet handles with bare hands. After hands are washed, use disposable towels to turn off faucet. Employee washed hands as corrective action.
- 13 3-302.11 Packaged and Unpackaged Food-Separation, Packaging, and Segregation - P Raw bacon stored above produce. Bread crumbs were not sealed in dry storage. Store raw animal products below ready-to-eat items in refrigeration. Bacon relocated as corrective action.
- 14 4-601.11 (A) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - P Plates, scoops, and slicer required additional cleaning. Wash, rinse, and sanitize utensils so that they are clean to sight and touch. Utensils sent to be rewashed as corrective action. Slicer will be cleaned and placed in storage as per manager.
 4-703.11 Hot Water and Chemical-Methods - P Quat. sanitizer weak in the bottles. Ensure quat. sanitizer is mixed to 150-400 ppm for sanitizing. Remove sticker residue from the outside of lids and containers.

- 21 3-501.17 Ready-To-Eat Potentially Hazardous Food (Time/Temperature Control for Safety Food), Date Marking - PF Date marking for chicken in the freezer was not legible. Ensure items are date marked to include the date prepared, date frozen, and date thawed for items that are prepared and frozen in the facility.
- 26 7-202.12 Conditions of Use - P,PF Quat. sanitizer concentration in bucket was >400 ppm. Ensure sanitizer is mixed and used according to the manufacturer's specifications.
- 31 3-501.15 Cooling Methods - PF Chicken salad cooling in large portion. Ensure items are cooling in thin, small portions.
- 34 4-302.12 Food Temperature Measuring Devices - PF One of two thermometers was not working properly. Ensure battery is changed and FTMD's are calibrated properly.
- 36 6-501.111 Controlling Pests - PF Seal gaps around the air conditioning units to prevent the entrance of pests. Recommend removing units and using central air conditioning system.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C Repair damaged shelf in the beverage area.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - C Clean shelving in the dry storage room, inside refrigeration units, and under the steam table. Clean inside microwave. Clean window sills in the kitchen.
