- 41 3-304.12 In-Use Utensils, Between-Use Storage - C Handle of scoop in contact with sugar. Keep handle out of food products.
- 45 4-202.16 Nonfood-Contact Surfaces - C Replace containers for air-drying at the 3 comp. sink. Replace sterilite containers that are not easily cleanable.
4-501.11 Good Repair and Proper Adjustment-Equipment - C Milk was 47 F in the 3 door refrigerator. Lower temperature to maintain food at 45 F or below. Repair ice buildup on the walk-in freezer.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - C Cart for food storage required additional cleaning. Keep cart clean. Clean under the seams of the shelving in the service counter. Clean shelves next to the desk. Clean shelving in the storage closet. Clean raw wood in the storage unit used for emergency water.
- 53 6-201.11 Floors, Walls and Ceilings-Cleanability - C Provide cleanable floors and walls in the outside storage area.
6-501.12 Cleaning, Frequency and Restrictions - C Clean floors in the corner of the dry storage area.
6-201.13 Floor and Wall Junctures, Coved, and Enclosed or Sealed - C Seal baseboards to the wall in the coffee making area.
6-201.17 Walls and Ceilings, Attachments - C Ductwork for the ventilation system is not easily cleanable. Attachments to ceilings must be easily cleanable.
- 54 6-303.11 Intensity-Lighting - C Light is not provided in the outside walk-in cooler. Provide lighting at 10 f/c in the storage areas.
