Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 43 3-304.12 In-Use Utensils, Between-Use Storage. Observed scoop in ready to eat ham and handle had fallen in the food. Store in-use utensils in a clean, dry place, in food with handles out, in 135F or greater water or in running water which quickly moves food particles to the drain.
- 56 6-202.11 Light Bulbs, Protective Shielding. Observed light cover in walk in freezer cracked. Light bulbs shall be shielded, coated, or otherwise shatter-resistant in areas where there is exposed food; clean equipment, utensils, and linens; or unwrapped single-service and single-use articles. Light in walk in freezer is shatter resistant and PIC removed cracked cover.
