## Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 53 6-501.12 Cleaning, Frequency and Restrictions - C: Cleaning is needed on floors under fryer. Physical facilities shall be cleaned as often as necessary to keep them clean.
- 54 6-303.11 Intensity-Lighting - C: The light in the walk-in cooler measured at 5 ft candles. The light intensity shall be 10 foot candles 30 inches above the floor in walk-in refrigeration units.
