

- 56 6-303.11 Intensity - Lighting (C)The light intensity at the stove top range is reading low (30 foot candles). The light intensity shall be at least 50 foot candles at a surface where a food employee is working with food. Replace the missing light blubs in the hood system to raise the amount of light intensity to at least 50 foot candles.
