- 47 4-602.13 Nonfood Contact Surfaces - C: Cleaning needed on storage shelves. Nonfood-contact surfaces of equipment shall be cleaned at a frequency necessary to preclude accumulation of soil residues. 0-points
- 53 6-501.12 Cleaning, Frequency and Restrictions - C: Cleaning on freezer floor under shelves, floors under bakery storage shelves, and floors and walls behind fryers. Physical facilities shall be cleaned as often as necessary to keep them clean.
