Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 37 3-305.11 Food Storage-Preventing Contamination from the Premises - C- Boxes of chicken, potatoes and muffins were stored on the floor beneath the shelves inside of the walk-in freezer (WIF)- Food shall be protected from contamination by storing at least 6 inches off of the floor- 0 pts.
- 45 4-501.11 Good Repair and Proper Adjustment-Equipment - C- REPEAT- Repair or replace the torn door gasket for the walk-in freezer (WIF) and replace the non-functioning light bulbs in the exhaust hood above the fryers- Equipment shall be maintained in a state of good repair.
- 47 4-601.11 (B) and (C) Equipment, Food-Contact Surfaces, Nonfood-Contact Surfaces, and Utensils - C- REPEAT- Cleaning is needed on the speed rack used for baked goods, the door gasket for the Walk-in cooler, the door tracks for the deli meat display case, the undersides of the drainboards for the 3 compartment sink and the floor and baseboards of the walk-in freezer- Nonfood contact surfaces of equipment shall be kept free of an accumulation of food residue, dust, dirt and other debris.
- 53 6-501.12 Cleaning, Frequency and Restrictions - C- REPEAT- Cleaning is needed for the floor and baseboards beneath the shelves inside of the walk-in cooler- Physical facilities shall be maintained clean.
