### Observations and Corrective Actions

Violations cited in this report must be corrected within the time frames below, or as stated in sections 8-405.11 of the food code.

- 1 2-102.11 Demonstration-REPEAT - C: There was no food protection manager on duty during the inspection. The person in charge shall demonstrate knowledge of foodborne disease prevention, application of HACCP principles, and the requirements of this code by being a certified food protection manager.
- 47 4-602.13 Nonfood Contact Surfaces -REPEAT- C: Cleaning needed inside of the upright coolers and freezers to remove spills and food debris. Nonfood-contact surfaces of equipment shall be cleaned at a frequency to preclude accumulation of soil residue.
- 52 5-501.113 Covering Receptacles-REPEAT - C:The door of the outside recyclable observed open. Receptacles and waste handling units for refuse, recyclables, and returnables shall be kept covered.
- 53 6-501.11 Repairing-Premises, Structures, Attachments, and Fixtures-Methods - C: Recaulk around toilets in men and women's restroom. Physical facilities shall be maintained in good repair.// 6-501.12 Cleaning, Frequency and Restrictions - C: Wall cleaning needed on walls in men and women's restroom. Physical facilities shall be cleaned as often as necessary to keep them clean.
